How are imports regulated in the Dominican Republic?

Imports are regulated by the Direcci#243;n General de Aduanas (DGA)-- the Dominican Customs Authority. The country participates in the CAFTA-DR (Dominican Republic-Central America-United States Free Trade Agreement),allowing duty-free entry for many U.S. products. All shipments must be declared,and duties and VAT may apply.
