Does Oman need an environmental impact assessment (EIA)?

In accordance with national legislation (MD 48/2017), the Project is classified as a Category 'A' activity and requires an Environmental Impact Assessment (EIA). The EIA A (also known as ESIA A) received approval from Oman's Environmental Authority in July 2024, along with the associated permit conditions.

What is the area of influence for North Oman solar PV project?

The area of influence (AoI) for the North Oman Solar PV Project extends 15 km around the site, located in the Ad Dakhiliyah Governorate, specifically in the Wilayat of Adam. Within 5 km of the site, there are no settlements or residential areas.

What is environmental protection in Oman?

Environmental protection within Oman is primarily governed by the "Law for the Conservation of the Environment and the Prevention of Pollution" (Royal Decree 114/2001) which is managed by the Environmental Authority (EA), formerly known as the Ministry of Environment and Climate Affairs (MECA).
