Do foreign inland freight charges occur after shipment to the United States?

The Court of International Trade ("CIT") held that the charges in question, foreign inland freight and related charges included in the CIF prices, did not "occur after the merchandise ha[d] been sold for export to the United States and placed with a carrier for through shipment to the United States", as required by 19 CFR §167.152.103(a)(5)(iii).

Are costs or charges for post importation transportation excluded from transaction value?

The costs or charges for post importation transportation may be excluded from transaction value if they are identified separately from the price actually paid or payable. An exclusion for post importation transportation will be based on any reasonable cost or charge.

Which containers need to be bonded and grounded during dispensing?

All containers of Category 1, 2, or 3 liquids (with a flashpoint lower than 100°F) need to be bonded and grounded during dispensing. This can include dispensing from or to non-metallic containers, even though the container material may not be recognized as conductive (for example, polyethylene and IBC-type containers).
